4.1. Description of first aid measures

Eye Contact	<p>If this product comes in contact with the eyes:</p> <ul style="list-style-type: none"> Immediately hold eyelids apart and flush the eye continuously with running water. Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. Transport to hospital or doctor without delay. Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.
Skin Contact	<p>If spilt on skin:</p> <ul style="list-style-type: none"> Remove contaminated clothing, swab repeatedly with glycerin, PEG (polyethylene glycol), or PEG/ methylated spirit mixture or if necessary with methylated spirit alone* Contamination of skin with phenol and some of its derivatives may produce rapid collapse and death. After skin contamination, keep patient under observation for at least 24-48 hours. Phenol-decontaminating fluid is more effective than water in removing phenol from the skin and retarding absorption; olive oil or vegetable oil may also be used; do not use mineral oil. Alcohols* (methylated spirit, for example) may enhance absorption and their use alone may be ill-advised; some authorities however continue to advise the use of such treatment. Rapid water dilution of phenol burns may increase systemic absorption by decreasing the extent of the coagulum and thus allowing greater absorption (1). <p>(1) Ellenhorn and Barceloux: Medical Toxicology: Diagnosis and Treatment of Human Poisoning.</p>
Inhalation	<ul style="list-style-type: none"> If fumes or combustion products are inhaled remove from contaminated area. Lay patient down. Keep warm and rested. Prostheses such as false teeth, which may block airway, should be removed, where possible, prior to initiating first aid procedures. Apply artificial respiration if not breathing, preferably with a demand valve resuscitator, bag-valve mask device, or pocket mask as trained. Perform CPR if necessary. Transport to hospital, or doctor, without delay.
Ingestion	<ul style="list-style-type: none"> For advice, contact a Poisons Information Centre or a doctor at once. Urgent hospital treatment is likely to be needed. If swallowed do NOT induce vomiting. If vomiting occurs, lean patient forward or place on left side (head-down position, if possible) to maintain open airway and prevent aspiration. Observe the patient carefully. Never give liquid to a person showing signs of being sleepy or with reduced awareness; i.e. becoming unconscious. Give water to rinse out mouth, then provide liquid slowly and as much as casualty can comfortably drink. Transport to hospital or doctor without delay.

4.3. Indication of any immediate medical attention and special treatment needed

For thiocyanate poisonings haemodialysis is recommended as the treatment of choice. Phenobarbital protects poisoned animals against death. Thiocyanate ion is slowly excreted in the urine and is not decomposed to any appreciable degree to cyanide.

Several members of this family of compounds, containing heavy metals tend to explosive instability, and most are capable of violent oxidation under certain circumstances. ▶ Fusion of mixtures of metal cyanides with metal chlorates, perchlorates, nitrates or nitrites cause violent explosion. ▶ Magnesium reacts with incandescence on heating with several metal cyanides; release of cyanogen by thermal decomposition may cause vigorous reaction with magnesium. ▶ Addition of one solid component (even in residual amounts) to another molten component is extremely dangerous. <p>BREThERICK L.: Handbook of Reactive Chemical Hazards</p> <ul style="list-style-type: none"> ▶ Nitriles may polymerise in the presence of metals and some metal compounds. ▶ They are incompatible with acids; mixing nitriles with strong oxidising acids can lead to extremely violent reactions. ▶ Nitriles are generally incompatible with other oxidising agents such as peroxides and epoxides. ▶ The combination of bases and nitriles can produce hydrogen cyanide. Nitriles are hydrolysed exothermally in both aqueous acid and base to give carboxylic acids (or salts of carboxylic acids). ▶ Nitriles can react vigorously with reducing agents. ▶ The covalent cyano group is endothermic and many organic nitriles are reactive under certain conditions; N-cyano derivatives are reactive or unstable. ▶ The majority of endothermic compounds are thermodynamically unstable and may decompose explosively under various circumstances of initiation. ▶ Many but not all endothermic compounds have been involved in decompositions, reactions and explosions and, in general, compounds with significantly positive values of standard heats of formation, may be considered suspect on stability grounds. <p>BREThERICK L.: Handbook of Reactive Chemical Hazards</p> <ul style="list-style-type: none"> ▶ Phenols are incompatible with strong reducing substances such as hydrides, nitrides, alkali metals, and sulfides. ▶ Avoid use of aluminium, copper and brass alloys in storage and process equipment. ▶ Heat is generated by the acid-base reaction between phenols and bases. ▶ Phenols are sulfonated very readily (for example, by concentrated sulfuric acid at room temperature), these reactions generate heat. ▶ Phenols are nitrated very rapidly, even by dilute nitric acid. ▶ Nitrated phenols often explode when heated. Many of them form metal salts that tend toward detonation by rather mild shock. ▶ Segregate phenol from halogens, calcium hypochlorite, and metals such as aluminium, lead, zinc, magnesium. ▶ Reaction of phenol with calcium hypochlorite is exothermic and produces toxic fumes which may ignite ▶ Hot phenol is corrosive to many metals, including aluminium, lead, magnesium and zinc. ▶ Do not heat phenol above 60 deg.C. ▶ Avoid reaction with oxidising agents

8.2. Exposure controls

8.2.1. Appropriate engineering controls	<p>Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection. The basic types of engineering controls are:</p> <p>Process controls which involve changing the way a job activity or process is done to reduce the risk.</p> <p>Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. Ventilation can remove or dilute an air contaminant if designed properly. The design of a ventilation system must match the particular process and chemical or contaminant in use.</p> <p>Employers may need to use multiple types of controls to prevent employee overexposure.</p>											
	<p>Local exhaust ventilation usually required. If risk of overexposure exists, wear approved respirator. Correct fit is essential to obtain adequate protection. Supplied-air type respirator may be required in special circumstances. Correct fit is essential to ensure adequate protection. An approved self contained breathing apparatus (SCBA) may be required in some situations.</p> <p>Provide adequate ventilation in warehouse or closed storage area. <p>Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. Where the chemical is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.</p>

The exact break through time for substances has to be obtained from the manufacturer of the protective gloves and has to be observed when making a final choice.

Personal hygiene is a key element of effective hand care. Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended.

Suitability and durability of glove type is dependent on usage. Important factors in the selection of gloves include:

- frequency and duration of contact,
- chemical resistance of glove material,
- glove thickness and
- dexterity

Select gloves tested to a relevant standard (e.g. Europe EN 374, US F739, AS/NZS 2161.1 or national equivalent).

· When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time greater than 240 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended.

· When only brief contact is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended.

· Some glove polymer types are less affected by movement and this should be taken into account when considering gloves for long-term use.

· Contaminated gloves should be replaced.

As defined in ASTM F-739-96 in any application, gloves are rated as:

- Excellent when breakthrough time > 480 min
- Good when breakthrough time > 20 min
- Fair when breakthrough time < 20 min
- Poor when glove material degrades

For general applications, gloves with a thickness typically greater than 0.35 mm, are recommended.

It should be emphasised that glove thickness is not necessarily a good predictor of glove resistance to a specific chemical, as the permeation efficiency of the glove will be dependent on the exact composition of the glove material. Therefore, glove selection should also be based on consideration of the task requirements and knowledge of breakthrough times.

Glove thickness may also vary depending on the glove manufacturer, the glove type and the glove model. Therefore, the manufacturers technical data should always be taken into account to ensure selection of the most appropriate glove for the task.

Note: Depending on the activity being conducted, gloves of varying thickness may be required for specific tasks. For example:

- Thinner gloves (down to 0.1 mm or less) may be required where a high degree of manual dexterity is needed. However, these gloves are only likely to give short duration protection and would normally be just for single use applications, then disposed of.
- Thicker gloves (up to 3 mm or more) may be required where there is a mechanical (as well as a chemical) risk i.e. where there is abrasion or puncture potential

Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended.

- ▶ Cartridge respirators should never be used for emergency ingress or in areas of unknown vapour concentrations or oxygen content.
- ▶ The wearer must be warned to leave the contaminated area immediately on detecting any odours through the respirator. The odour may indicate that the mask is not functioning properly, that the vapour concentration is too high, or that the mask is not properly fitted. Because of these limitations, only restricted use of cartridge respirators is considered appropriate.
- ▶ Cartridge performance is affected by humidity. Cartridges should be changed after 2 hr of continuous use unless it is determined that the humidity is less than 75%, in which case, cartridges can be used for 4 hr. Used cartridges should be discarded daily, regardless of the length of time used
- Respirators may be necessary when engineering and administrative controls do not adequately prevent exposures.
- The decision to use respiratory protection should be based on professional judgment that takes into account toxicity information, exposure measurement data, and frequency and likelihood of the worker's exposure - ensure users are not subject to high thermal loads which may result in heat stress or distress due to personal protective equipment (powered, positive flow, full face apparatus may be an option).
- Published occupational exposure limits, where they exist, will assist in determining the

adequacy of the selected respiratory protection. These may be government mandated or vendor recommended.

- Certified respirators will be useful for protecting workers from inhalation of particulates when properly selected and fit tested as part of a complete respiratory protection program.

SECTION 11 Toxicological information

11.1. Information on toxicological effects

Inhaled	<p>The material can cause respiratory irritation in some persons. The body's response to such irritation can cause further lung damage. Hydrogen chloride (HCl) vapour or fumes present a hazard from a single acute exposure. Exposures of 1300 to 2000 ppm have been lethal to humans in a few minutes.</p> <p>Inhalation of HCl may cause choking, coughing, burning sensation and may cause ulceration of the nose, throat and larynx. Fluid on the lungs followed by generalised lung damage may follow.</p> <p>Breathing of HCl vapour may aggravate asthma and inflammatory or fibrotic pulmonary disease.</p> <p>High concentrations cause necrosis of the tracheal and bronchial epithelium, pulmonary oedema, atelectasis and emphysema and damage to the pulmonary blood vessels and liver.</p> <p>If phenols are absorbed via the lungs, systemic effects may occur affecting the cardiovascular and nervous systems. Inhalation can result in profuse perspiration, intense thirst, nausea, vomiting, diarrhoea, cyanosis, restlessness, stupor, falling blood pressure, hyperventilation, abdominal pain, anaemia, convulsions, coma, swelling and inflammation of the lung.</p> <p>Inhalation of the phenol vapour produced sore throat, coughing, laboured breathing and systemic effects including paleness, weakness, headache, sweating, ringing sound in the ears, low blood oxygen, and even shock. It can also produce a damaging effect on the lungs, heart muscles, liver, kidney and hind-limb paralysis based on studies done with guinea-pig.</p> <p>Inhalation of vapours, aerosols (mists, fumes) or dusts, generated by the material during the course of normal handling, may produce toxic effects.</p>
Ingestion	<p>Toxic effects may result from the accidental ingestion of the material; animal experiments indicate that ingestion of less than 40 gram may be fatal or may produce serious damage to the health of the individual.</p> <p>The material can produce chemical burns within the oral cavity and gastrointestinal tract following ingestion.</p> <p>A number of materials such as cyanamide, calcium cyanamide, cyanates, isocyanates, isonitrile, thiocyanates, ferricyanide and ferrocyanide, and cyanoacetates do not exhibit the same toxic effects as cyanides and nitriles.</p> <p>Some phenol derivatives can cause damage to the digestive system. If absorbed, profuse sweating, thirst, nausea, vomiting, diarrhoea, cyanosis, restlessness, stupor, low blood pressure, gasping, abdominal pain, anaemia, convulsions, coma and lung swelling can happen followed by pneumonia.</p> <p>For phenol, solid:</p> <p>Ingestion causes blotches on the lips and in the mouth.</p> <p>Probable lethal dose of thiocyanate (rhodanate), in man, is between 15 and 30 gm (ingested at one time). Several acute fatalities are recorded with death coming in 10 to 48 hours.</p>
Skin Contact	<p>Skin contact with the material may produce toxic effects; systemic effects may result following absorption.</p> <p>The material can produce chemical burns following direct contact with the skin.</p> <p>Phenol and its derivatives can cause severe skin irritation if contact is maintained, and can be absorbed to the skin affecting the cardiovascular and central nervous system. Effects include sweating, intense thirst, nausea and vomiting, diarrhoea, cyanosis, restlessness, stupor, low blood pressure, hyperventilation, abdominal pain, anaemia, convulsions, coma, lung swelling followed by pneumonia.</p> <p>Open cuts, abraded or irritated skin should not be exposed to this material</p> <p>Entry into the blood-stream, through, for example, cuts, abrasions or lesions, may produce systemic injury with harmful effects. Examine the skin prior to the use of the material and ensure that any external damage is suitably protected.</p> <p>For phenol, solid:</p> <p>Contact with the skin causes a white, wrinkled discolouration, followed by a severe burn or whole-body poisoning if not promptly and properly removed.</p> <p>Intense burning and pain from skin contact may be delayed. Absorption through the skin may cause extreme danger; in one case, a person who spilled a solution of phenol over much of his body, died 10 minutes later. Skin absorption occurs at low vapour pressure, without apparent discomfort. Damage to the lungs, methaemoglobin in the blood, and breakage of red blood cells with anaemia are frequently documented.</p>
Eye	<p>The material can produce chemical burns to the eye following direct contact. Vapours or mists may be extremely irritating.</p> <p>If applied to the eyes, this material causes severe eye damage.</p> <p>Some phenol derivatives may produce mild to severe eye irritation with redness, pain and blurred vision. Permanent eye injury may occur; recovery may also be complete or partial.</p> <p>The vapour when concentrated has pronounced eye irritation effects and this gives some warning of high vapour concentrations. If eye irritation occurs seek to reduce exposure with available control measures, or evacuate area.</p>
Chronic	<p>Repeated or prolonged exposure to corrosives may result in the erosion of teeth, inflammatory and ulcerative changes in the mouth and necrosis (rarely) of the jaw. Bronchial irritation, with cough, and frequent attacks of bronchial pneumonia may ensue.</p> <p>Long-term exposure to respiratory irritants may result in airways disease, involving difficulty breathing and related whole-body problems.</p> <p>Based on experiments and other information, there is ample evidence to presume that exposure to this material can cause genetic defects that can be inherited.</p> <p>Toxic: danger of serious damage to health by prolonged exposure through inhalation, in contact with skin and if swallowed.</p> <p>This material can cause serious damage if one is exposed to it for long periods. It can be assumed that it contains a substance which can produce severe defects.</p> <p>Ample evidence exists from experimentation that reduced human fertility is directly caused by exposure to the material.</p> <p>Substance accumulation, in the human body, may occur and may cause some concern following repeated or long-term occupational exposure.</p> <p>Chronic minor exposure to hydrogen chloride (HCl) vapour or fume may cause discolouration or erosion of the teeth, bleeding of the nose and gums; and ulceration of the mucous membranes of the nose. Workers exposed to hydrochloric acid suffered from stomach inflammation and a number of cases of chronic bronchitis (airway inflammation) have also been reported. Repeated or prolonged exposure to dilute solutions of hydrogen chloride may cause skin inflammation.</p> <p>Long-term exposure to phenol derivatives can cause skin inflammation, loss of appetite and weight, weakness, muscle aches and pain, liver damage, dark urine, loss of nails, skin eruptions, diarrhoea, nervous disorders with headache, salivation, fainting, discolouration of the skin and eyes, vertigo and mental disorders, and damage to the liver and kidneys.</p> <p>There has been some concern that this material can cause cancer or mutations but there is not enough data to make an assessment.</p> <p>Solid phenol is highly toxic if swallowed, inhaled or on skin contact. Chronic phenol poisoning is very rarely reported, but symptoms include vomiting, difficulty in swallowing, diarrhoea, lack of appetite, headache, fainting, dizziness, dark urine, mental disturbances, possibly skin rash and death due to liver and kidney damage may occur.</p> <p>Repeated exposure of animals to phenol vapour at concentrations ranging from 26 to 52 ppm has produced respiratory, cardiovascular, liver, kidney and neurologic toxicity and may produce blood cancers in mice on oral exposure.</p>

Thus the complete absence of thiocyanate or reduced thiocyanate in the human body, (e.g., cystic fibrosis) is damaging to the human host defense system</p> <p>Thiocyanate [SCN⁻] is a complex anion which is a potent inhibitor of iodide transport (the thyroid sodium-iodide symporter) iodine is an essential component of thyroxine. Since thiocyanates will decrease iodide transport into the thyroid follicular cell, they will decrease the amount of thyroxine produced by the thyroid gland. As such, foodstuffs containing thiocyanate are best avoided by iodide deficient hypothyroid patients</p> <p>Thiocyanate is the detoxification product of cyanide and can easily be measured in body fluids. Consumption of naturally occurring goitrogens, certain environmental toxins and cigarette smoke can significantly increase SCN⁻ concentrations to levels potentially capable of affecting the thyroid gland. Goiter endemics were reported to develop when the critical urinary iodine/ SCN⁻ ratio decreases below 3 microgram iodine per mg SCN⁻. Iodine supplementation completely reverses the goitrogenic influence of SCN⁻. SCN⁻ is also generated from cigarette smoking as a detoxifying product of cyanide. During the past two decades many reports dealt with the possible effects of cigarette smoking on thyroid hormone synthesis, thyroid gland size and thyroid autoimmunity including infiltrative ophthalmopathy of Graves' disease.</p> <p>Thiocyanates are derived from the hydrolysis of glucosinolates — sulfur-containing compounds found in cruciferous vegetables. Brassica species such as cabbage, broccoli, cauliflower, rutabaga, mustard, Brussels sprouts, and turnip contain glucosinolates (previously called thioglucosides) which are hydrolyzed to form isothiocyanates, nitriles, and thiocyanates</p>
	<p>The material may be irritating to the eye, with prolonged contact causing inflammation. For Phenols:

Ecotoxicity - Phenols with log Pow >7.4 are expected to exhibit low toxicity to aquatic organisms however; the toxicity of phenols with a lower log Pow is variable. Dinitrophenols are more toxic than predicted from QSAR estimates. Hazard information for these groups is not generally available.

For Thiocyanates:

Terrestrial Fate: Soil - At near ambient temperatures (approximately 30 C.) it appears that sorption and volatilization are not significant processes for thiocyanate in soil, with thiocyanate losses due primarily to microbial degradation. Thiocyanate is not persistent in soils. Thiocyanate may undergo both aerobic and anaerobic microbial degradation; however, the degradation pathway has not been defined. Saturated soils treated with thiocyanate were found to emit carbonyl sulfide (COS). Microbial degradation is the primary mechanism for thiocyanate disappearance at or below 30 C., with carbonyl sulfide as a possible hydrolysis product. Loss of thiocyanate at higher temperatures (50-60 C.) did not appear to result from microbial degradation.

Aquatic Fate: Biodegradation is a significant transformation process for thiocyanates in natural waters. Thiocyanate is toxic to microorganisms at high concentrations; however, acclimated cultures have increased tolerance to this compound. At concentrations up to 1.42 g/L., thiocyanate is completely degraded within 4 days to ammonia and sulfate ion (SO₄-2) by an acclimatized co-culture of two bacteria (Acinetobacter johnsonii and Pseudomonas diminuta).

For Phenol:

Environmental Fate: In alkaline soils and water, phenol will partially exist as an anion, (negatively charged particle), which can affect its fate and transport processes.

Atmospheric Fate: Phenol may wash out of the atmosphere with precipitation, however; this may occur on a limited basis, due to the short half-life of phenol in the air. During the day, when hydroxyl radical concentrations are highest, very little atmospheric transport of phenol is likely to occur. Gas-phase phenol will react with atmospheric hydroxyl radicals, which is a major removal process. The estimated half-life for phenol for this reaction is 0.61 days. The reaction of phenol with nitrate radicals during the night may constitute a significant removal process; the half-life for the substance at night is estimated to be 15 minutes. Phenol is not expected to be broken down by sunlight in the atmosphere.

Terrestrial Fate: Soil Phenol is biologically degraded in soil, under both oxygenated and low oxygen soil conditions breakdown under these conditions is expected to be rapid with virtually all of the substance degraded. The half-life of phenol in soil is generally <5 days, but acidic soils, and some surface soils, may have half-lives of up to 23 days. Half-lives for degradation of low concentrations of phenol in two silt loam soils were 2.70 and 3.51 hours. Plants do not accumulate phenol and have been shown to rapidly metabolize the substance.

Aquatic Fate: In water, evaporation and sorption to sediments/suspended particulates are not expected to be important transport mechanisms. Phenol will be broken down directly by sunlight in water and indirectly via reactions with hydroxyl radicals in water; typical half-lives for hydroxyl and peroxy radical reactions are on the order of 100 and 19.2 hours of sunlight, respectively. These reactions require dissolved natural organic materials in the water. Phenol is readily biodegradable in natural water, provided the concentration is not high enough to cause significant inhibition through microbial toxicity. The degradation of phenol is somewhat slower in salt water. Rapid degradation of phenol also has been reported in various sewage and water treatment processes.

Ecotoxicity: Phenol is not expected to concentrate significantly in aquatic organisms. The substance ranges from low to moderate toxicity to aquatic organisms.
